What is the overall <u>deductible</u> ?	\$2,000 person/\$4,000 family in-network and \$3,000 person/\$6,000 family out-of-network per calendar year.	Generally, you must pay all the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes, for in-network providers : preventive care, office visits, prescription drugs, and chiropractic services are covered before you meet your deductible .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
