# **Emergency School Closure 12/15/1/5**

Trustee Williams made a motion to approve the advertising for staffing needs for 2016-2017 as presented by Superintendent Graham: Full-time School Psychologist, Title I Teacher at FIS, Spanish Teacher at FHS, and additional Counselor at FHS. Trustee Bowman seconded the motion. Motion carried unanimously.

#### **Rehire of Football Coach**

Mr. Madsen addressed the board, asking to withdraw his recommendation of rehire of the Football Coach.

Trustee Williams made a motion not to rehire the Football Coach. Trustee Bowman seconded the motion. Motion carried unanimously.
