REGULAR BOARD MEETING

The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at the Filer Intermediate School, Filer, Idaho, on July 10, 2018 as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Trustee Williams made a motion to approve the revised agenda. Trustee Hoffman seconded the motion. Motion carried unanimously.

ORGANIZATION OF THE BOARD

CHAIRMAN

Trustee Williams nominated Trustee Jaynes as Chairman. Trustee Hoffman seconded the confirmation. Motion carried unanimously.

VICE-CHAIRMAN

Trustee Williams nominated Trustee Bowman for Vice-Chairman. Trustee Deetz seconded the motion. Motion carried unanimously.

CLERK

Trustee Williams made a motion to retain Teresa Kullhem as Clerk. Trustee Hoffman seconded the confirmation. Motion carried unanimously.

Dr. Graham is asking the board to approve an editorial change to the job descriptions listed, adding the words "lift and carry 50 pounds". This is to make these job description uniform with other current food service and custodial positions.

Public Records Custodian Designation

According to State law, the district needs to designate a custodian of public records. As clerk, Teresa Kullhem would be the one with easiest access to records, and Kyle Pryde would be a backup person.

G.26 – Professional Personnel Reemployment – Editorial Change

Dr. Graham presented updates to G.26 to reflect the changes in the categories of teacher according to ISBA guidelines. It also sets forth the time frame for return of teaching contracts to the district.

Salary Based Apportionment for Classified Employees 2018 ISBA Resolution

Filer School District is being asked to co-sponsor a resolution that will ask the ISBA to change the way that funding for classified salary is apportioned to the districts.
