#### **FMA Volleyball Program Changes**

Trustee Deetz made a motion to approve a B team volleyball program for the 7<sup>th</sup> and 8<sup>th</sup> grade, hiring two coaches at the 4% stipend rate. Trustee Jaynes seconded the motion. Trustee Williams and Trustee Hoffman opposed the motion. Motion failed.
