

**MINUTES OF THE REGULAR MEETING OF
BOARD OF TRUSTEES OF

TWIN FALLS COUNTY, STATE OF IDAHO
APRIL 20, 2021**

INFORMAL REVIEW

The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at the Filer Intermediate School Library, Filer, Idaho, on April 20, 2021 as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Present when the meeting began at 5:58 p.m. were Chairman Aaron Williams, Trustees Judy Hoffman, Julie Koyle, Bob Burnham, Superintendent Kelli Schroeder, and Clerk Teresa Kullhem.

Trustee Burnham made a motion to approve the agenda as presented. Trustee Hoffman seconded the motion. Motion carried unanimously.

An informal hearing took place at 6:00 p.m. in the district office conference room.

**EXECUTIVE SESSION
RESOLUTION TO RECESS FROM AN OPEN MEETING

The Chairman announced that the next order of business would be the consideration of the Board recessing into executive session for the purpose of conducting further business.

Community Input

Hearing Section School/Department Reports

Monthly reports from the schools and departments were presented for the board's review.

Consent Agenda

Chairman Williams approved all items on the consent agenda which included: Retirement/Resignation of Karen Fothergill, FHS Art; Jacob Kinghorn, FHS Social Studies, Track and Cross Country; Matt Lassen, FMS PE and Athletic Director; Mike Amaya, FHS girls basketball; Nora Sterett, FIS PSR; Kimberlee Cowger, FMS 8th Volleyball; and Anna Hess, HES/FIS ELL Para. Hire of Allie Brandsma, FIS 5th Grade Teacher; Kristan Young, ½ Athletic Director, ½ Teacher; and Cheyenne Olsen, FES Para. Fall teaching assignments for Hannah Holman and Chanelle Hughes at Filer Elementary School, with Brian Wolf as a Cooperating Ag Teacher for perspective teachers at the High School.

Budget Items Legislative Update

Superintendent Schroeder explained how the ESSER III funds are to be dispensed and how the State is estimating our shortage. The legislature is still in session and we are waiting for their vote on budget items.

Set 2020-2021 Revised Budget/2021-2022 Budget Hearing Date and Time

Trustee Koyle made a motion to move the hearing for both the 2020-2021 Revised Budget and 2021-2022 Budget Hearing for July 13, 2021 at 6:30 p.m.

Superintendent's Report School Calendar for 2021-2022

Discussion was held on the proposed calendars for next school year. There were two 4-day calendars and two 5-day calendars presented. Discussion was held on the pros and cons of the 4-day schedule. Each board member gave their thoughts on the move to a 4-day school week, and most were of the opinion that the district needs a year with a regular 5-day schedule to help students recover from their learning losses over the last year. Superintendent Schroeder feels the district needs to spend more time formulating a 4-day week plan. Trustee Koyle made a motion to keep the 5-day school week, starting after Labor Day in the fall, with early Friday release, and an end date of June 3, 2022. Trustee Hoffman seconded the motion. Trustees Williams, Burnham and Deetz opposed the motion. Motion failed. Trustee Burnham made a motion to adopt the 5A calendar as presented and voted on by the staff. Trustee Hoffman seconded the motion. Trustee Deetz opposed the motion. Motion carried.

FEA Intent to Negotiate

The Filer Education Association would like to reopen negotiations for 2020-2021 to correct the salary steps for certified teachers and open negotiations for the upcoming 2021-2022 school year. Trustee Hoffman made a motion to approve the FEA's letter of intent to negotiate. Trustee Burnham seconded the motion. Motion carried unanimously.

FHS Full-Time Assistant Principal Position

Superintendent Schroeder is asking the board to approve a full-time assistant principal at the high school. As Mr. Hild transitions to the high school, he feels that a full-time assistant principal would be beneficial to the students and would help with many aspects of discipline and other areas of high school administrative business. Trustee Deetz made a motion to approve the advertising and hire of a full-time assistant principal position at the high school, with a July 1, 2021, start date. Judy Hoffman seconded the motion. Motion carried unanimously.

Board training, presented by ISBA will be available next Tuesday the 27th at the CSI Taylor building. Trustees Hoffman, Burnham and Koyle will all be attending.

Chairman Williams adjourned the meeting at 8:48 p.m.
