The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at the Filer Intermediate School Library, Filer, Idaho, on June 14, 2022, as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Present when the meeting began at 6:00 p.m. were Chairman Julie Koyle, Trustees Ryan Gurney, Bill Deetz, Superintendent Kelli Schroeder, and Clerk Teresa Kullhem.

Trustee Gurney made a motion to approve the agenda as posted. Trustee Deetz seconded the motion. Motion carried unanimously.

Trustee Lanting entered the meeting at 6:03 p.m

Community Comment

Angela Lierman with Haywired Robotics Team and students from the Filer area, presented the robotics team along with their team goals and would like to ask the district for financial help in funding their program.

Amy Schutte with Salmon Falls Wind Project, Magic Valley Energy presented information on the windmill project that is slated to begin later this year. Community input is still being taken and she encouraged the district to be involved. The district could financially benefit if the projects come to fruition.

Maverick Presentation

Andres with Maverick is present at tonight's meeting to present plans for a new Maverick store in Filer. The store front doors fall less than 300 feet from Filer Middle School, so Maverick is requesting a letter from the District allowing them to build their store on the proposed property.

School/Department Reports

School/department reports, and year end goals were presented to the board as information. Principals presented to the board what they did in accomplishing goals that had been set for the year.

School Staffing

Superintendent Schroeder reviewed all the positions that still remain open for the next school year. The open positions at Hollister were discussed with the board acknowledging that it is going to be difficult to fill so many teaching positions at Hollister. Discussion was held on the shortage of qualified teachers.

Superintendent Evaluation

The Superintendent will be discussing her evaluation goals in executive session.
