MINUTES OF THE REGULAR MEETING OF BOARD OF TRUSTEES OF SCHOOL DISTRICT NO. 413, TWIN FALLS COUNTY, STATE OF IDAHO JUNE 13, 2023

The regular meeting of the Board of Trustees of School District No. 413, Twin Falls County, State of Idaho was held at Filer Intermediate School Library, Filer, Idaho, on June 13, 2023, as provided in section 33-510 and 67-2345 et seq. Idaho Code.

Trustee Burnham made a motion to approve the revised agenda as posted, adding an item to the consent agenda, an update on Hollister and an item for executive session. Trustee Lanting seconded the motion. Motion carried unanimously.

Superintendent's Report Hollister Elementary School Update

Superintendent Kelli Schroeder, Chairman Julie Koyle, and other Hollister community members met with BLUUM at Hollister Elementary School on Monday, June 12th, to determine the possibility of making HES a charter school beginning in the 2024-2025 school year. BLUUM had many positive things to say about Hollister's building, staff, and setup. There will be a community meeting held on July 6, 2023, at the Hollister Grange at 6:00 p.m. with BLUUM to discuss more details on the charter school possibility.

Date Change for July's Regular Board Meeting

A couple of board members will be out of town on the date of the regularly scheduled board meeting in July. It was decided to move the meeting to Thursday, July 20, 2023.

Trustee Deetz made a motion to move July's regularly scheduled board meeting to Thursday, July20, 2023. Trustee Lanting seconded the motion. Motion carried unanimously.

Ratification of Collective Bargaining Agreement for 2023-2024

Superintendent Schroeder noted that negotiations with the Filer Education Association had been completed for the year. The biggest change for this upcoming year is that the district was able to give the entire \$6359 to each teacher that the State had given on a per FTE rate. The district will also be working with the FEA to ensure that all policies in the master agreement align with the new policies that have been adopted by the district. Discussion on the agreement will be held in executive session.

District Summer Projects

Maintenance Director Layne Flint updated the board on summer projects that are happening. Fences have gone up around the bus barn with automatic gates to be added. A fuel station will also be installed. The building that will house the bus offices will also become home to the district administration office after some remodeling of the space that is currently occupied by the technology department. Remodeling of the auditorium is also included in what will be done using ESSR funds.

Superintendent Evaluation

The Superintendent's evaluation goals will be discussed in executive session.
